### **1.19 Tests, Pilots, Promotional Campaigns and Contests**

The Company may from time to time engage in special promotions of limited duration of its service offerings designed to attract new customers or to increase existing Customer awareness of a particular tariff offering. Waiver of any charges other than a nonrecurring charge shall be limited to 90 calendar days on a per customer basis during a 12-month period. Requests for promotional offerings will be presented to the Commission for its review in accordance with Case No. 95-845-TP-COI.

### **1.20 Interruption of Service**

Credit allowances for service interruptions which are not due to the Company's testing or adjusting, to the negligence of the Customer, or to the failure of channels, equipment or communications systems provided by the Customer, are subject to the general liability provisions set forth in Section 1, paragraph 1.6 herein, and shall be made in conformance with 4901:1-5-18 O.A.C. It shall be the obligation of the Customer to notify Company immediately of any interruption in service for which a credit allowance is desired. Before giving such notice, Customer shall ascertain that the trouble is not within his or her control, or is not in wiring or equipment, if any, furnished by Customer and connected to Company's terminal.

### **1.21 Cost of Collection and Repair**

The Customer is responsible for any and all costs incurred in the collection of past due monies due the Company including legal and accounting expenses incurred by the Company's use of collection agencies or use of legal action. Customer is also responsible for recovery costs of Company-provided equipment and any expenses required for repair or replacement of damaged equipment.

### **1.22 Returned Check Charges**

There is a minimum charge of \$15 and a maximum charge of \$35 for each check returned for insufficient funds. The Company will charge \$25 for each check returned for insufficient funds. This charge may be waived under appropriate circumstances. (I)
