


Memorandum in Support

Duke Energy Ohio, Inc. initiated this proceeding with the filing of an application on June 29, 2012. The Office of the Ohio Consumers' Counsel and Ohio Partners for Affordable Energy submitted interventions on July 25, 2012 and July 30, 2012, respectively. On August 89, 2012, the Attorney Examiner issued a procedural schedule that included, *inter alia*, a date for hearing of November 6, 2012.

On October 25, 2012, the Company submitted a Stipulation and Recommendation that was signed by all of the Parties and resolves the matters raised in the Parties' earlier filed Comments. It is anticipated that Duke Energy Ohio witness Timothy J. Duff will testify in support of the Stipulation and Recommendation. Mr. Duff is located in Charlotte, North Carolina and will travel to Ohio to testify. As Mr. Duff will be in Ohio for other matters on November 7, 2012, it is respectfully requested that the hearing on this matter be moved one day so that Mr. Duff need not unnecessarily change his travel date. As all of the Parties in this proceeding have jointly submitted the Stipulation and Recommendation, it is anticipated that the hearing to be held will not be lengthy. Additionally, all of the Parties who will attend the hearing on this Stipulation and Recommendation will likewise be at the offices of the Commission on November 7 for other business reasons, therefore the change of date is expedient for all of the Parties.

Wherefore, the Joint Movants respectfully request that the hearing of this matter be set one day later, to November 7, 2012.


