4 THE HEARING EXAMINER: Scheduled for
5 hearing before the Public Utilities Commission of
6 Ohio at this time are Case Nos. 05-120-GA-FOR,
7 04-220-GA-GCR, and 05-220-GA-GCR. All three cases
8 involve Vectren Energy Delivery of Ohio Incorporated
9 and related matters.

10 I am Greta See, the attorney-examiner
11 assigned to this case by the Commission.

12 At this time I would like to take
13 appearances of the parties.

14 On behalf of Vectren.

15 MS. HUMMEL: Thank you, your Honor. On
16 behalf of Vectren Energy Delivery of Ohio the law
17 firm of McNees, Wallace & Nurick, by Samuel C.
18 Randazzo, and Gretchen J. Hummel, 21 East State
19 Street, Columbus, Ohio.

20 THE HEARING EXAMINER: On behalf of OCC.

21 MR. SERIO: Thank you, your Honor, on
22 behalf of the residential utility customers of
23 Vectren, Janine Migden Ostrander, Consumers Counsel,
24 by Joseph P. Serio.

1 THE HEARING EXAMINER: IGS.

2 MS. HUMMEL: Your Honor, I have been
3 authorized to mark their exhibit for identification
4 purposes, so I suspect I'm am authorized to enter
5 their appearance today.

12 MR. LINDGREN: On behalf of the
13 Commission Staff, Attorney General Jim Petro, Senior
14 Deputy Attorney General Duane Luckey, Assistant
15 Attorneys General Thomas Lindgren and Werner Margard,
16 180 East Broad Street, Ninth Floor, Columbus, Ohio,
17 43215.

18 THE HEARING EXAMINER: Let the record
19 reflect that Mr. Singh has just joined us.

20 MR. SINGH: Thank you, your Honor.

21 THE HEARING EXAMINER: Ms. Hummel.

22 MS. HUMMEL: Your Honor the parties have
23 already met once and have distributed a document with
24 the intent of settling all of the issues in this

1 proceeding. Those discussions are ongoing, and are
2 progressing positively at this time. We would like
3 to continue this hearing because we anticipate that
4 the issues will be settled rather rapidly. We would
5 suggest we not set another date. Instead, we will
6 let you know if the talks break down and it appears
7 as if we will require an evidentiary hearing in this
8 proceeding, and I promise you we don't intend to drag
9 this thing out.

10 THE HEARING EXAMINER: Okay. Do the rest
11 of the parties agree?

12 MR. SERIO: Yes, your Honor.

13 MR. LINDGREN: Yes, the staff agrees.

14 MR. SINGH: I agree, your Honor.

15 THE HEARING EXAMINER: That being the
16 case, I will expect to get a joint e-mail updating me
17 of the status in negotiations. If they have not been
18 resolved by November 17, an e-mail will be fine.

19 If, however, things are not resolved by
20 January 1, 2007, I'll go ahead and schedule a
21 hearing.

22 MS. HUMMEL: Thank you, Your Honor.

23 THE HEARING EXAMINER: Okay.

24 MS. HUMMEL: If you are agreeable, we

1 thought we could take care of a couple housekeeping
2 matters today, and to that end, we have prepared a
3 document which is an exhibit list for all of the
4 documents, prefiled testimony in the docket in the
5 proceeding, and as well reserving a number for a
6 late-filed exhibit, proofs of publication when
7 they're available, and, finally, anticipating a
8 settlement, we've reserved an exhibit number for the
9 Stipulation and Recommendation in the proceeding.

10 Rather than read all of these in the
11 record if, everyone agrees, the court reporter can
12 simply reflect the contents of the document in the
13 transcript today.

14 MR. SERIO: That's acceptable your Honor.

15 MR. LINDGREN: Yes.

16 MR. SINGH: No objections your Honor.

17 MS. HUMMEL: The only other thing we need
18 to do is to deal with the issue of the
19 confidentiality of one of the exhibits of IGS, and if
20 it's okay with you, it's my understanding that IGS
21 has waived confidentiality with respect to the
22 exhibit, so the copy of the testimony of Kraig
23 Lotter, which has been provided to the court reporter
24 today, and I am providing the court reporter copies

1 of all testimonies prefiled testimony in the
2 proceeding, these proceedings, all three of them.

3 THE HEARING EXAMINER: Okay. Mr. Singh.

4 MR. SINGH: That is correct. IGS does
5 waive confidentiality of Exhibit No. 3 attached to
6 Kraig Lotter's testimony, and, your Honor, I have a
7 copy of that for you as well.

8 THE HEARING EXAMINER: Okay. I assume
9 there are no objections to the admission of any of
10 the exhibits included on the list.

11 MS. HUMMEL: Well, I think it is
12 premature to admit them into evidence, your Honor,
13 but the stipulation will provide for the admission of
14 them into evidence at the point at which it is
15 executed, but I think today we simply wanted to
16 identify them for the record so that managing
17 identification later on would be easier and we
18 wouldn't have to reconvene for that purpose, only
19 that purpose.

20 THE HEARING EXAMINER: Okay.

21 MS. HUMMEL: And I believe the attorney
22 general, assistant attorney general, has brought
23 copies of all of the audits filed in case for the
24 court reporter as well.

1 MR. LINDGREN: Yes. I will be giving
2 them to the reporter.

3 THE HEARING EXAMINER: Okay. Is there
4 anything else?

5 MR. LINDGREN: No your Honor.

6 MR. SERIO: No, your Honor.

7 MR. SINGH: Nothing, your Honor. Thank
8 you.


9 THE HEARING EXAMINER: That being the
