MEMORANDUM IN SUPPORT

The OCC requests a subpoena, pursuant to Ohio Adm. Code 4901-1-25, to command Buzz Telecom, to make available the officers, agents, employees, or other persons with the appropriate knowledge and experience to provide fact information concerning Buzz Telecom's past and current operations in Ohio and this sale and transfer of assets from Buzz Telecom to UMCC Holdings, Inc. in order to submit to oral examination at deposition on January 22, 2007 at the offices of the OCC (10 W. Broad Street, 18th Floor, Columbus, Ohio 43215) at 1:00 p.m. as on cross-examination by the OCC in the above-captioned proceedings and to attend from day to day until the deposition is completed.

The above-captioned case involves the operations of Buzz Telecom as being investigated by the PUCO. It is critical that the appropriate representative of Buzz Telecom appear in order to provide in-depth information regarding these matters. The full participation of the appropriate representative of Buzz Telecom in the examination will facilitate a full and complete development of the case, including the ultimate record

upon which the Commission will base its decision. The representative of Buzz Telecom should have the knowledge and experience to answer questions regarding all aspects of the company's operations.

Additionally, the OCC requests the PUCO to command Buzz Telecom to provide, for delivery to OCC at the outset at the examination, documents relevant to the deposition, as detailed in this Motion above, i) copies of all scripts used by Buzz Telecom sales representatives in soliciting new customers, ii) tapes and recordings of the third-party verification process utilized by Buzz Telecom to verify telephonic enrollments, iii) copies of the welcome packet sent to each newly enrolled customer, iv) copies of any customer contracts utilized by Buzz Telecom, v) copies of the recordings of all third-party telephonic enrollments for Buzz's customers in Ohio, vi) copies of documents, including a corporate balance sheet, that contain information regarding Buzz Telecom's total revenue for 2006, vii) copies of documents, containing the account information for each former and current customer of Buzz Telecom in Ohio, and viii) copies of documents pertaining to the sale or transfer of assets from Buzz Telecom to UMCC Holdings, Inc. This information is central to understanding and addressing the issues related to Buzz Telecom's operations in Ohio.
