

Upon application of Counsel for the Office of the Ohio Consumers' Counsel ("OCC"), Buzz Telecom, Corporation ("Buzz Telecom") is hereby required to make available the appropriate officers, agents, employees, or other persons with the appropriate knowledge and experience to provide fact information concerning Buzz Telecom's past and current operations in Ohio to appear for oral examination on January 22, 2007 at the offices of the OCC (10 W. Broad Street, 18th Floor, Columbus, Ohio 43215) at 1:00 p.m., and attend day to day until completed, and submit to oral testimony by cross examination upon deposition by the OCC regarding Case Nos. 02-2617-CT-ACE and 06-1443-TP-UNC. In addition, you are required at said time and place to provide to the OCC

- i) copies of all scripts used by Buzz Telecom sales representatives in soliciting new customers, ii) a description of the third-party verification process utilized by Buzz Telecom used to verify telephonic enrollments, iii) copies of the welcome packet sent to each newly enrolled customer, iv) copies of any customer contracts utilized by Buzz Telecom, v) copies of the recordings of all third-party telephonic enrollments for Buzz's

customers in Ohio, vi) documentation, including a corporate balance sheet that indicates Buzz Telecom's total revenue for 2006, vii) documentation including the account information for each former and current customer of Buzz Telecom in Ohio, and viii) copies of documents pertaining to the sale or transfer of assets from Buzz Telecom to UMCC Holdings, Inc.
