APPLICATION OF KNG ENERGY, INC. FOR APPROVAL OF A NEW BILL FORMAT

By its entry of March 2, 2005 in Case No. 03-888-AU-ORD, the Commission directed natural gas and/or electric distribution utilities that had not yet responded to the Commission's August 11, 2004 entry in that docket to submit copies of their current bill formats for staff review to confirm compliance with recently-enacted Rule 4901:1-18-09, Ohio Administrative Code ("OAC"). At that time, KNG Energy, Inc. ("KNG") was in the process of revising its bill format and securing new billing software. Thus, rather than submitting a copy of its then-current bill format, KNG submitted its proposed bill format to the staff for review. As a result of subsequent discussions with staff, KNG made certain modifications to its proposed bill format to comply with the requirements of the new rule. Accordingly, by this application filed pursuant to Rule 4901:1-18-09(C), OAC, KNG now seeks Commission approval of the new bill format attached hereto as Exhibit A. Exhibit A includes the front and back of the regular customer bill, as well as the formats for budget customer bills, the display of past due amounts and credits, and the display of non-recurring charge information.

Because KNG has no percentage of income payment plan ("PIPP") customers, it has this date also filed a motion in Case No. 03-888-AU-ORD seeking a waiver of the Rule 4901:1-18-
