# MEMORANDUM IN SUPPORT OF MOTION FOR PROTECTIVE ORDER

Pursuant to Ohio Administrative Code Chapter 4901-1-24(A)(7), Telecom Management, Inc. d/b/a Pioneer Telephone ("Pioneer") respectfully requests that the Ohio Public Service Commission enter an Order to protect the confidentiality of its financials submitted under seal as Exhibit 10 to its Application for a Certificate of Public Convenience and Necessity to Provide Resold Local Exchange Services in Ohio.

Pioneer submits that this exhibit contains trade secret information protected under Ohio Law. In determining whether information is a "trade secret," the Ohio Supreme Court "examines: (1) whether the information is otherwise known or available; (2) what precautions [Pioneer] used to guard the secrecy of the information; (3) the value of the information among [Pioneer's] competitors; (4) the time and effort expended to obtain the claimed secret; (5) the time and effort others would expend to otherwise get the information; and (6) whether [Pioneer] treated the information as confidential. The information for which Pioneer seeks protection satisfies each of these factors. Pioneer does not normally disclose information regarding its accounting system. Pioneer treats such information as confidential and has implemented internal policies and procedures to ensure that such information is not publicly disclosed. Pioneer further asserts that this information could and would

be utilized by Pioneer's competitors to the detriment of Pioneer and Ohio consumers. Pioneer has obtained protective seals for their financial information in an application filed in the state of Connecticut, and has requested protective financial treatment in applications pending in the states of Georgia and Texas. Therefore, Pioneer requests that the Commission accord this information proprietary and confidential treatment and not release it to the public.
