
**MOTION OF OHIO POWER COMPANY FOR WAIVER OF THE 90-DAY
FILING REQUIREMENT PURSUANT TO SECTION 4906-5-02, OHIO
ADMINISTRATIVE CODE**

Pursuant to Sections 4906-1-03, 4906-1-05 and 4906-5-02, Ohio Administrative Code ("O.A.C.") and for good cause shown, Ohio Power Company (hereinafter "AEP") moves for waiver of the 90-day filing requirement found in Section 4906-5-02(A)(1), O.A.C., in order to permit AEP to begin construction on the Hanthorn – G.O. Ethanol 138 kV Line Project in April, 2007.

MEMORANDUM IN SUPPORT

Concurrent with the filing of this motion, AEP is filing a Letter of Notification for its Hanthorn-G.O. Ethanol 138 kV Line Project. This project involves provision of electric service to a new G.O. Ethanol station for dedicated service to the new Greater Ohio Ethanol Facility in Lima, Ohio ("G.O.E. Facility"). The G.O.E. Facility is currently under construction.


Greater Ohio Ethanol will soon be constructing the new distribution station that will provide dedicated service to the G.O.E. Facility. Greater Ohio Ethanol has requested 138 kV service from AEP by September 1, 2007 to support its construction and testing schedules. In order to meet the customer's service needs and not disrupt its construction schedule, AEP requests a waiver of the 90-day notice requirement contained in OAC Rule 4906-5-2(A)(1). The company avers that no harm would result from granting the requested waiver.

AEP requests, therefore, that the Board find that good causes exists to waive the 90-day filing requirement and permit the company to begin construction of the instant project April, 2007.

WHEREFORE, AEP moves that the Board grant the requested waiver.
