With regard to Dominion Field Services, Inc. 's (Applicant) application to abandon its certificate to provide competitive retail natural gas service (CRNGS); Certificate Number G02-044(2), and its operations under that certificate, staff finds that the Applicant has fulfilled its obligation pursuant to Rule 4901:1-27-11 of the Ohio Administrative Code. As such, Applicant's request to abandon CRNGS Certificate Number G02-044(2), and its operations thereunder, was hereby granted, effective February 4, 2007. The granted application effectively cancels Dominion Field Services, Inc.'s operating authority. Dominion Field Services, Inc. is no longer authorized to provide CRNGS service in the State of Ohio.
