
**MOTION OF OHIO POWER COMPANY FOR WAIVER OF THE 90-DAY
FILING REQUIREMENT PURSUANT TO SECTION 4906-5-02, OHIO
ADMINISTRATIVE CODE**

Pursuant to Sections 4906-1-03, 4906-1-05 and 4906-5-02, Ohio Administrative Code ("O.A.C.") and for good cause shown, Ohio Power Company (hereinafter "AEP") moves for waiver of the 90-day filing requirement found in Section 4906-5-02(A)(1), O.A.C., in order to permit AEP to begin construction on the Portsmouth – Trenton 138 kV Line #1 Project in April, 2007 on or about April 16, 2007 and be completed by May 25, 2007.

WHEREFORE, for the reasons described in the attached Memorandum in Support, AEP respectfully requests that the waiver requested herein be granted.



MEMORANDUM IN SUPPORT

Concurrent with the filing of this motion, AEP is filing a Letter of Notification for its Portsmouth-Trenton 138 kV Line #1 Project. This project involves tapping the existing Portsmouth – Trenton 138 kV Line #1 and installing approximately 180' of new 138 kV transmission line to serve a new distribution station owned and operated by Dayton Power and Light proposed distribution station. The existing circuit to be tapped is the Hillsboro – Hutchings 138 kV Circuit.


DP&L has constructed a new distribution station in Harlan Township, Warren County, Ohio. DP&L has requested service to this station from AEP's Portsmouth – Trenton 138 kV Line #1. The reasons for the installation of the station are provided in DP&L's Letter of Notification (OPSB Case # 04-1383-EL-BLN). At the request of DP&L, AEP is committed to install and energize this distribution tap prior to the Summer peak-loading season.

AEP requests, therefore, that the Board find that good causes exists to waive the 90-day filing requirement and permit the company to begin construction of the instant project on or about April 16, 2007..

WHEREFORE, AEP moves that the Board grant the requested waiver.
