

The tariff changes included in this tariff filing are as follows:

Paper Billing Charge

Subscribers that receive their monthly bill via regular mail shall be charged \$0.99 per month. The Paper Billing Charge shall be waived for subscribers that receive their monthly bill via email.

EZPay Credit

Subscribers that receive their monthly bill via email and remit payment of their monthly invoice automatically via debit or credit card or automatic withdrawal from a checking account shall not be billed a Paper Billing Charge and shall receive a credit of \$1.00 per month.

The purpose of implementing these items is to encourage IDT's customers to receive their bills in a more cost-efficient, environmentally-friendly manner and to permit IDT to more fully recover its costs for those customers that prefer to receive their IDT bill and to remit payment using the mail, rather than electronically. These items will apply equally to residential and business customers. These items are neither a switched nor dedicated service.
