Re: In the matter of the authorization of CSX Transportation to construct active grade crossing warning devices in Crawford, Franklin, Medina and Union Counties
Date: March 8, 2007

The Ohio Rail Development Commission (ORDC) has authorized CSX Transportation (CSX) to construct active grade crossing warning devices at the following locations:

Crawford County, Polk Township, Biddle Rd/TR 44, DOT# 262-041C

Franklin County, City of Worthington, Huntley Rd, DOT# 518-948D

Franklin County, City of Columbus, Scioto Darby Rd, DOT# 513-323N

Medina County, York Township, Stone Rd/TR 74, DOT# 142-492A

Union County, Paris Township, Dogleg Rd/TR 136, Paris Township, DOT# 513-821X

These crossings were surveyed in November and December 2006 and were found to warrant upgrades.

These projects are actual cost and will be funded with federal funds. Staff requests an Entry with plans and estimates to be submitted to the Commission and ORDC within 90 days, and construction to be completed within one year. Upon approval of the plans and estimates by ORDC construction may commence. A suggested case coding and heading would be:
