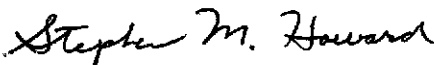

On November 30, 2006, an Abandonment Application was filed in the above cases pursuant to Rule 4901:1-27-11 of the Ohio Administrative Code on behalf of MidAmerican Energy Company ("MidAmerican"). Over 90 days have passed and under Rule 4901:1-27-11 of the Ohio Administrative Code, the Abandonment Application is automatically approved. MidAmerican will file its final annual report as a competitive retail natural gas service provider in Ohio on or before April 30, 2007.
