**3.0 Description of Services Offered****3.1 Local Service****3.1.1 Nature of Service**

Local Service is a service that allows customers to originate non-toll local calls at locations within the service areas in which McLeodUSA has been approved for certification for termination within the local calling area (including any applicable EAS areas) of those locations. Subject to service availability and the package selection by the customer, Local Service may include services in addition to those required for completion of non-toll local calls (including services which may not be subject to regulation under this tariff) which are purchased as part of a bundled package.

**3.1.2 Availability**

McLeodUSA offers local service in the areas in which it has been certified by the Ohio Public Utilities Commission and in which McLeodUSA has available required network facilities or is able to lease required network facilities to enable the offering of service. Some features may not be available in all areas, or may slightly vary between service areas contingent on network availability or configuration. McLeodUSA will provide the most feature rich version of a feature in the bundled Local Service package available in a given market depending on network availability or configuration.

**3.1.3 Local Service Packages**

The standard elements of local line packages consist of local dial tone and unlimited local calling unless otherwise noted in a Service specific description. Mandatory extended area service ("EAS") is provided where applicable for the prices set forth in the Rate Tables. Customers with multiple lines at a single location may purchase different Packages for each telephone line at a particular location. A Local Line Price Adjustment ("LLPA") is applied to recover the increased costs (rate increases to specific portions of Unbundled Network Elements (UNE's) purchased from suppliers) of providing local telecommunications service. A LLPA is applied to each business local line that was established prior to November 21, 2005 and is served via McLeodUSA switched facilities (see Section 6.1). The Local Line Price Adjustment will not be applied to new Preferred Advantage lines added to your account on or after November 21, 2005 if you are served via McLeodUSA switched facilities. A Local Line Price Adjustment is applied to each business local line that was established prior to January 19, 2006 and is not served via McLeodUSA local switching facilities (see Section 6.1). The Local Line Price Adjustment will not be applied to new Preferred Advantage lines added to your account on or after January 19, 2006 if you are not served via McLeodUSA local switching facilities. Business Customers purchasing a Business Package may select a long distance package of anytime minutes for each location, which shall be shared by all lines serving that Customer location. Business Customers purchasing Local Service Packages are also eligible to purchase a per minute long distance service that offers reduced long distance rates due to the purchase of bundled package of local and long distance services from McLeodUSA. Residential Customers shall select a long distance package of anytime minutes for each location, which shall be shared by all lines serving that Customer location.

## **McLeodUSA Telecommunications Services, Inc. ("McLeodUSA")**

### **Description:**

McLeodUSA is decommissioning several Collocations in Ohio (City, CLLIs as listed in Section 6.1 of the McLeodUSA Tariff-2 in Ohio: Berea, BERE0H23; Cleveland, BKPK0H26; Dayton, DYTNOH23; Dayton, DYTNOH25; Bedford, BDFROH23; Chagrin Falls, SOLNOH24; and Solon, SOLNOH24) because the costs to maintain each collocation exceeds the revenue derived from that collocation. Accordingly, the business and residential customers in these collocations that were served via McLeodUSA local switch facilities (UNE platform) have been moved from a UNE Platform to a Resale Platform in January and/or February 2007. Attached following this Description, are copies of the notices informing the customers of the transition and associated impacts of the move. No pricing adjustments were made at the time of the platform migration.

This tariff change reflects the increased pricing for providing the services to these business and residential customers that are now on the Resale platform in the above mentioned Central Offices. Because the current business and residential customers are now receiving their services via the Resale Platform, the rates for these services are being adjusted due to the costs associated with the Resale Platform. From the time of the customers transitioned to a Resale platform until the forthcoming effective date of this tariff, McLeodUSA has been absorbing the additional costs associated with providing these services to these business and residential customers on a Resale Platform.

**Regarding Impacted Business Customers:** Some background on the Local Line Price Adjustment ("LLPA") will provide some clarity and understanding to the pricing adjustments in this tariff filing. Due to some federal regulatory changes, McLeodUSA applied an LLPA to our business customers that were under contracts at that time. An LLPA of \$3.00 was applied to each business local line that was established prior to November 21, 2005 and is served via a UNE Platform; and a LLPA of \$13.00 for Zone 3, and \$12.00 for Zone 4 were applied to each business local line established prior to January 19, 2006 that was not served via a UNE platform. (See tariff Sheet Nos. 51 and 110 in Exhibit A of this tariff filing.) Business customers served via a Resale platform that either 1) came to McLeodUSA after January 19, 2006 or renewed their contracts after January 19, 2006 no longer have the LLPA applied. Rather, those customers would/will have the higher package rates applied. Likewise, business customers served via a UNE platform that either 1) came to McLeodUSA after November 21, 2005 or renewed their contracts after November 21, 2005 no longer have the LLPA applied. These business customers would/will have the higher package rates applied. The LLPA will eventually phase out as the existing contracts established prior to January 19, 2006 or



November 21, 2005, depending on the customers platform, expire or terminate. After these dates, new business customers do not have the LLPA applied.

Returning back to the application of this tariff. McLeodUSA offers a variety of packages to business customers who are served via a UNE platform. However, McLeodUSA currently offers only the OneLine Preferred Package (Package A) to business customers on a Resale Platform. To preserve the current services the business customers have today (meaning those packages that the business customers have because they were on a UNE platform), McLeodUSA is grandfathering these central offices in Section 7.37, beginning on Sheet No. 242.27. This will allow the current business customers to maintain their packages even on the Resale platform to which they were migrated.

The first focus will be on the business customers, which can be broken into three (3) groups: a) New business customers after April 12, 2007 (referencing the effective date of this tariff); b) Impacted business customers that are operating under existing contracts; and c) Impacted business customers that are operating under expired contracts, also known as month-to-month rate basis. There are no current impacted customers in group a, new customers after April 12, 2007. Accordingly, the price for the OneLine Preferred Package A is increased to \$40.95, consistent with the current pricing for Package A on a Resale platform. Also, the Local Line Price Adjustment ("LLPA") has been reduced to \$0.00 because there are and will no longer be any business customers that would qualify for an LLPA (see the language in Section 3.1.3 on Sheet No. 51 and Section 5.3.1 on Sheet No. 110, under Exhibit A of this tariff filing). These are the rate changes are reflected on Sheet Nos. 141, 142, 143, 144 and 144.4.

All impacted business customers that are currently operating under a existing contracts, group b, will remain with the current pricing for the UNE Platform, and any LLPA that may currently be in place, for the duration of their contract. When the contract expires, the new pricing, consistent with the Resale platform pricing, which they are currently on, will be implemented. Customers will not be renewed at the existing UNE platform pricing rates.

The impacted business customers that are operating month-to-month, group c, will have their pricing adjusted in a separate filing, which is to be forthcoming. Per discussion with the staff, adjusting LLPA for those customers that currently have an LLPA is not an option at this time in this type of filing.

**Regarding Impacted Residential Customers:** Though McLeodUSA offers a several packages to residential customers who are served via a UNE platform, McLeodUSA does not currently offer any packages to residential customers on a Resale platform. (See Sheet Nos. 145.1 and 145.2.) To preserve the current services the residential customers have today (meaning those packages that the residential customers have because they were on a UNE platform), McLeodUSA is grandfathering these central offices in Section 7.37, beginning on

Sheet No. 242.27. Consequently, all impacted residential customers are being grandfathered and moved to section 7.37 in this tariff filing. Note that there is not an LLPA applied to any of these impacted residential customers. Also, there are no contracts for residential customers, so all pricing for these customers is being increased effective within this filing. The impacted residential customers can be broken into two (2) groups: a) impacted residential customers that have packages currently available on the UNE platform; and b) impacted residential customers that have packages that were grandfathered previously because the packages are no longer available to new customers.

The residential customers in group a are addressed in Section 7.37(A), (B) and (C). The information regarding impacted residential customers in group b were copied from grandfathered section 7.35 (Sheet Nos. 242.23, 242.24 and 242.25) and are addressed in Section 7.37(D). Section 7.37 reflects the increased rates that account for the change from a UNE Platform to a Resale Platform.

**Rationale:**

McLeodUSA's rationale for the decommissioning of the collocations and the price adjustments are to help McLeodUSA be competitive within the market place.

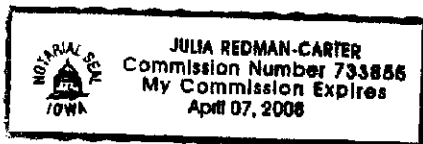
