Submitted as an electronic filing are revisions to United Telephone Company of Ohio d/b/a/ Embarq P.U.C.O. No. 1 Access Service Tariff. These revisions are filed in compliance with the April 25, 2007 Finding and Order in Case No. 07-464-TP-COI. That Order authorizes Embarq to add exceptions to Ohio's intrastate tariff to exclude the shortfall penalty associated with the Premier Term Discount Plan. In addition, Ethernet Transport service and the special access OptiPoint configuration cards and SONET OC Ring interfaces used in conjunction with Ethernet Transport service are excluded from Ohio's intrastate jurisdiction. This filing should be processed as a zero day filing, to become effective April 27, 2007.
