In November, 2005, you inquired to the Ohio Power Siting Board regarding the proposed American Municipal Power Ohio, Inc. (AMP-Ohio) generating station. At that time, no application had been received by the Board and a letter was sent to you stating that if an application was received by the Board, your comments would be placed on the official docket.

This letter is a follow-up to inform you that AMP-Ohio filed an application to the Ohio Power Siting Board for a Certificate of Environmental Compatibility and Public Need on May 4, 2007 and therefore, your letter of November 2005 has now become part of the official docket for this case.

Presently Staff is reviewing the application for completeness. After Staff has concluded its investigation, the applicant will be required to provide further public notice regarding a future public hearing specific to the OPSB investigation for this project. I am not sure who to contact. ODNR said power plant licensing is not in their jurisdiction.

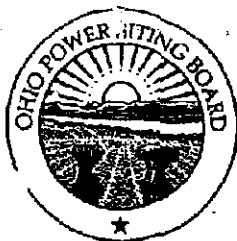
