
**MOTION OF COLUMBUS SOUTHERN POWER COMPANY FOR WAIVER OF
THE 90-DAY FILING REQUIREMENT PURSUANT TO SECTION 4906-5-02,
OHIO ADMINISTRATIVE CODE**

Pursuant to Sections 4906-1-03, 4906-1-05 and 4906-5-02, Ohio Administrative Code ("O.A.C.") and for good cause shown, Columbus Southern Power Company (hereinafter "AEP") moves for waiver of the 90-day filing requirement found in Section 4906-5-02(B)(1), O.A.C., in order to permit AEP to begin construction on the Hyatt – Genoa 138 kV Temporary Line Relocation Project on July 2, 2007.

WHEREFORE, for the reasons more fully described in the attached Memorandum in Support, AEP respectfully requests that the waiver requested herein be granted.

MEMORANDUM IN SUPPORT


This project involves a 138kV temporary line relocation of approximately 0.13 miles in length. Concurrent with this waiver request, AEP filed a Construction Notice regarding this project. The City of Westerville has requested that AEP remove (2) spans and (1) structure of the Hyatt-Genoa 138 kV line, that conflict with construction of their proposed station. Based on the City of Westerville's request, CSP is requesting a waiver of the sixty-day waiting period so we can commence construction, thirty days after filing of this Construction Notice. The waiver has been requested to move the line as soon as possible, so Westerville's station construction can be scheduled to receive large equipment before the possible return of eagles to a nesting site in the vicinity of the temporary line and station. The station equipment has been ordered and will ship in September 2007. Site work and foundations must be ready by September 2007. If the eagles return, possibly late Fall, all line and station construction will be terminated until the eagles leave the nesting site.

AEP requests, therefore, that the Board find that good causes exists to waive the 60-day filing requirement and permit the company to begin construction of the instant project July 2, 2007.

WHEREFORE, AEP moves that the Board grant the requested waiver.
