Complainants, by and through counsel, state and aver as follows:

- Defendant is Toledo Edison, a public electric utility company located in the State of Ohio, whose address is 300 Madison Avenue, Toledo, OH 43604.
- 2. Complainant is a resident of Montgomery Township, Wood County, Ohio. Toledo Edison currently provides electric service to much of Montgomery Township. However, Toledo Edison has provided inadequate service to the area in question. During the period of 1999 and 2000, the following feeder outages occurred in the Village of Wayne:

July 23, 1999	8:52 p.m.	203 Minutes	Lightning
July 29, 1999	1:27 p.m.	193 Minutes	Transformer fuse, only affected customers in 100 blocks of W. Main odds) and W. South (evens).

August 6, 2000	10:15 p.m.	405 Minutes	Lightning - Replaced 5 spans of conductor, 3 arrestors and the fuse
December 11, 2000	10:48 p.m.	102 Minutes	Wind - Broken Pole

- 3. Additionally, Toledo Edison has inadequate capacitors and equipment in Montgomery Township that have not been updated for thirty to forty years. Many residences have been built in the area, adding to the already burdened equipment. There are also potential health concerns with the older transformers as PCB's potentially exist in said transformers.
- 4. Complainant, through counsel, initially contacted Toledo Edison by letter regarding the inadequate service and a desire to change electric providers to Hancock-Wood Electric Cooperative, Inc. on October 12, 2000. Pursuant to OAC 4901:1-10-21(B), each electric service company shall investigate customer/consumer complaints and PROVIDE A STATUS REPORT WITHIN THREE BUSINESS DAYS OF THE DATE OF RECEIPT OF THE COMPLAINT to the customer/consumer, when investigating a complaint made directly to the electric service company. Such status report was not provided to complainants or their attorney in the required time frame.
- 5. A Petition has been signed by a significant number of residents of Montgomery

  Township requesting that Hancock-Wood Electric Cooperative, Inc. provide electric

  service to their respective households. See attached Exhibit "A".

Wherefore, Complainant requests an order directing that Hancock-Wood Electric Cooperative, Inc. provide electric service to Complainant and terminating Toledo Edison's service to said Complainant's household. Complainant alternatively requests such other and/or further relief as may be provided for by law or regulation.
