Dear Ms. Jenkins:

On behalf of SBC Long Distance, LLC, d/b/a AT&T Long Distance ("AT&T Long Distance"), I am submitting this Notice to the Public Utilities Commission of Ohio ("Commission") of AT&T Long Distance's intent to discontinue providing local exchange service in Ohio.

AT&T Long Distance¹ began providing local exchange service in Ohio pursuant to the commitment it made in Case No. 98-1082-TP-AMT. The Company agreed to provide local competition in four new markets where AT&T Ohio was currently not the incumbent local exchange carrier at the time of the Ameritech/SBC merger. These markets include: Cincinnati, Lebanon/Mason, Hudson/Twinsburg and Delaware/Cheshire. More specifically, AT&T Long Distance committed to offer residential service in each market for at least 36 months. At any time after having offered such service for 36 months in a market, the agreement afforded AT&T Long Distance the discretion to request, subject to Commission approval, to offer service in any market on a more limited basis up to and including withdrawal from the market. On this same date, AT&T Long Distance has filed Case No. 07-724-TP-ABN, seeking to discontinue providing local exchange services in all four market areas.

AT&T Long Distance has provided residential service pursuant to this commitment for the requisite amount of time. The chart below identifies the date on which local exchanges services were first offered in each market area.

¹ On May 24, 2005, the Ohio Commission issued a new certificate to SBC Long Distance, LLC, combining the IXC authority that SBCLD previously had in Ohio and the CLEC authority that SBC Telecom had in Ohio into a new certificate (No. 90-9146). On March 31, 2006, in Case No. 06-0033-TP-CIO, the certificate was modified to reflect the name of the additional d/b/a, AT&T Long Distance.
