Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

<u>Transmittal No. 834</u> – Effective August 2, 2007 With this transmittal, Verizon is revising FCC No. 14 based on discussions with FCC staff to withdraw the tariff material previously filed before the FCC under Transmittal 828 prior to that transmittal's effective date. Transmittal 828 introduced regulations to support the ongoing reliability of Verizon's SS7 network.
