With this filing, Ameritech is proposing to clarify and enhance the existing Optical Ethernet Metropolitan Area Network (OPT-E-MAN®) and Gigabit Ethernet Metropolitan Area Network (GigaMAN®) Services. This filing includes the following revisions: 1) Adding language in the tariff with specific location requirements for multipoint-to-multipoint service; 2) Adding multicast traffic clarification regarding multipoint-to-multipoint service and improved broadcast traffic throughput for point-to-point and point-to-multipoint service; 3) Adding Ethernet Virtual Channel clarification language regarding Grade of Service and Committed Information Rate (CIR) requirements; 4) Adding new language in the tariff to upgrade and move policies; 5) Revising the OPT-E-MAN® Termination Liability example; 6) Adding clarification of waived Non-Recurring Charges (NRCs) for Basic and Basic Plus Connection for 2, 3 and 5-year terms for new service; 7) Correcting the rates for 150 Mbps and 175 Mbps (CIR); and 8) Waiving the GigaMAN® NRCs for Administrative, Design and Central Office Connection and Customer Connection for 36 and 60-month terms for new service.
