

Dear Ms. Jenkins:

Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 853 – Effective September 21, 2007 With this transmittal, Verizon is revising FCC No. 14 to issue the second phase in a series of planned filings to align its credit allowance regulations. Specifically, exceptions to the credit allowance provisions are being aligned, where possible, across Verizon's regions. Also with this filing, Verizon will commence providing credits on eligible services for missed installation due dates on expedited orders and on orders for installation at a new standard premine. Sections are being renumbered and aredit for installation at a non-standard premise. Sections are being renumbered and credit allowance regulations are being re-ordered and moved into the Service Level Agreement section of the tariff.
