On June 29, 2007, AT&T Long Distance submitted notice to the Public Utilities Commission of Ohio ("Commission") of its intent to discontinue providing local exchange service in Ohio, effective 10-1-2007, pursuant to the commitment it made in Case No. 98-1082-TP-AMT, pending regulatory approval.

At this time, AT&T Long Distance hereby notifies the Commission that it is seeking to extend the effective date for discontinuing the provision of local exchange services in Ohio to October 9, 2007.
