Pursuant to Ohio Administrative Code Rule 4901-1-21(E) and 4901-1-20, the deponent is requested to produce at the time of his deposition all documents relating to his testimony in this proceeding or responses to discovery, including, but not limited to, the results of studies done for this proceeding and any backup documentation, including raw data, for those studies. The deponent is also requested to produce at the time of his deposition, any documents, studies or reports performed, produced or reviewed by or for Columbia related to safety issues relating to customer owned service lines, the impact on customers if customer service lines were to be owned and maintained by Columbia instead of the customer, and any documents relating to the implementation of the Columbia proposed Infrastructure Replacement Program ("IRP").
