 - A waiver of applicable non-recurring charges
 - An American Express Reward Card valued at \$120.00
 - A calling certificate, made payable to Verizon, valued at \$40.00 which will serve as a discount toward the monthly recurring charges for the selected usage plan
- 2) Customers who agree to convert their service from another local exchange provider and subscribe to at least one business exchange line plus an Unlimited Toll Usage for Business term plan will receive:
 - A waiver of applicable non-recurring charges
 - A calling certificate, made payable to Verizon, valued at \$40.00 which will serve as a discount toward the monthly recurring charges for the selected usage plan

American Express Reward Cards are awarded for each eligible billed telephone number with a term subscription.

Calling certificates are made payable to Verizon and are redeemable with bill payment by mail. Certificates are to be applied to the customer's Verizon telephone bill for tariffed charges, excluding taxes and surcharges.

This promotional offer is subject to the termination liability agreement pursuant to the tariff. Customers who disconnect service or change to another Alternative Local Exchange Carrier prior to the end of this agreement will be charged back for the promotion offer amount (rebate amount plus waived nonrecurring charges).
