8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

With this transmittal, Verizon is proposing the following revisions:

- References to several operating territories that Verizon has previously sold are removed from Tariffs F.C.C. Nos. 14, 16, and 21.
- References to several issuing carriers whose names have been changed is revised in Tariffs F.C.C. Nos. 1, 11, 14, 16, 19, 20, and 21. Changes to the names of issuing carriers include Verizon Southwest Inc., which changed to GTE Southwest Incorporated d/b/a Verizon Southwest Inc., and Verizon North Systems Inc., which changed to Contel of the South Inc. d/b/a Verizon North Systems Inc.
- Statement regarding original effective date of tariff added to the Title Page of Tariffs F.C.C. Nos. 1, 11, 16, 19, and 21.
- References to National Exchange Carrier Association, Inc. (as they pertain to Lifeline Assistance and Universal Service Fund) are removed from Tariffs F.C.C. Nos. 1, 11, 14, and 16.
- The spelling of the Lenape PA rate center is corrected in Tariff F.C.C. No. 1.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).


