ENTRY

The Commission finds:

- (1) On February 28, 2007, the Commission issued an entry in this case directing all jurisdictional utilities and railroads to file, by April 30, 2007, their annual reports for calendar year 2006. Every certified competitive retail electric service provider, gas marketer and governmental aggregator was ordered to file its appropriate form of the annual report.
- (2) The utilities on the appendix to this entry have failed to file their 2006 annual reports. The certificates and tariffs of the utilities listed on the appendix should be cancelled and the companies will be removed from the Commission's rolls of public utilities. Companies whose certificates and tariffs have been canceled may not provide public utility service in the state of Ohio. Companies that continue to provide service after the cancellation of their certificates and tariffs will be subject to a more severe penalty.

It is, therefore,


ORDERED, That the companies set forth on the appendix immediately notify all of their Ohio jurisdictional customers, if any, that they are no longer operating in Ohio. It is, further,

ORDERED, That the certificates and tariffs of utilities listed on the appendix are cancelled and the companies are removed from the Commission's rolls of public utilities. It is, further,






