This office is serving as local counsel for TelCove Operations, LLC, formerly known as TelCove Operations, Inc. The request at Case No. 06-1462-TP-ACN seeks approval of a name change from TelCove Operations, Inc. to TelCove Operations, LLC as the licensed holder for Certificate of Public Convenience & Necessity No. 90-9071 ("Certificate No. 90-9071"). The request was filed in December of 2006, but finalization has been delayed pending completion of the necessary filings with the Ohio Secretary of State to register TelCove Operations, LLC as a foreign limited liability company licensed to conduct business in Ohio.
