**JOINT APPLICATION TO TRANSFER A CERTIFICATE
TO FIRSTENERGY GENERATION CORP.**

Joint Applicants are Fremont Energy Center LLC ("Fremont"), holder of a Certificate of Environmental Compatibility and Public Need granted by the Ohio Power Siting Board ("Board") on May 21, 2001 and as corrected, modified or amended by the Entry Nunc Pro Tunc of June 18, 200, and the Entries dated December 15, 2003 and January 10, 2005 in this proceeding, and FirstEnergy Generation Corp. ("FirstEnergy"), the proposed transferee (together, "Joint Applicants").

In its May 21, 2001 Opinion, Order and Certificate, the Board approved the construction of a 704¹ megawatt electric combined-cycle, natural gas generating facility in Fremont, Sandusky County, Ohio. The Fremont facility is now approximately 70% complete.

Joint Applicants have entered into an agreement whereby all the assets of this project, including the Certificate, permits and other authorizations pertaining to the Fremont facility, will be transferred to FirstEnergy. FirstEnergy plans to continue construction of the Fremont facility in accordance with the Certificate issued by the Board on May 21, 2001 and June 18, 2001, respectively. It pledges to comply with the terms, conditions and modifications contained in the


Certificate, as evidenced by the attached correspondence from Mr. Ali Jamshidi, Vice President, FirstEnergy Generation Corp.

Ohio Revised Code Section ("R.C.") 4906.04 applies to a change in ownership of the Certificate where a new third-party entity proposes to acquire the certificate and provides that the Board determine whether a certificate should be transferred to the new third-party entity and, if so, to approve the transfer.


