Further, the adjudicatory hearing will commence on Wednesday, May 21, 2008, at 10:00 a.m., at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, 11<sup>th</sup> floor. Hearing Room F, Columbus, Ohio 43215-3793.
