ENTRY

The attorney examiner finds:

- (1) On December 28, 2007, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO) filed this application pursuant to Section 4929.04, Revised Code, for approval of phase two of its plan to exit the merchant function and requesting a general exemption of certain natural gas commodity sales services or ancillary services contained in Chapters 4905, 4909, 4933, and 4935, Revised Code.
- (2) By entry issued February 2, 2008, the attorney examiner, *inter alia*, established March 10, 2008, as the deadline for intervention in this case.
- (3) On January 1, 2008, Ohio Partners for Affordable Energy (OPAE) filed a motion for admission *pro hac vice* to admit David C. Rinebolt to practice before the Commission in this proceeding. Likewise, on February 13, 2008, National Energy Marketers Association (NEM) filed a motion for admission *pro hac vice* to admit Craig G. Goodman to practice before the Commission in this proceeding. The attorney examiner finds that OPAE's and NEM's motions for admission *pro hac vice* should be granted.
- (4) Motions to intervene in this case were timely filed by OPAE, NEM, Northeast Ohio Public Energy Council (NOPEC), Ohio Gas Marketers Group (OGM), MXenergy, Inc. (MXenergy), Dominion Retail, Inc. (Dominion Retail), Industrial Energy Users-Ohio (IEU-Ohio), Integrys Energy Services, Inc. (Integrys), and the Office of the Ohio Consumers' Counsel (OCC). In their motions to intervene, the movants submit that they meet the standards for intervention pursuant to Section 4903.221, Revised Code, and Rule 4901-1-11, Ohio


It is, therefore,


