**Business Sense Intrastate Promotion**

Sprint will offer to new and existing Business Sense customers subscribed or subscribing to a Business Sense \$200, \$500, \$750, \$2,000, or \$4,000 commitment level non-term, 1-year or 2-year term plan and enrolled or enrolling in the Business Sense Credit Promotion are eligible to receive a promotional rate of \$0.12 per minute on their Ohio in-state Business Sense Outbound and Business Sense Toll Free switched voice service usage. Sprint Business Sense customers who are currently enrolled in a Business Sense Term or non-term Plan will receive this promotional rate for 24 invoices or until customer terminates it's Business Sense Service.

**Real Solutions Business Environment Promotion**

The customer's new sales agreement will supersede its existing sales agreement. This provision will not apply if the customer decides to: (i) reduce its telecommunications services use for reasons unrelated to a sale or disposition or business downturn; (ii) change its telecommunications network architecture; or (iii) transfer part of its telecommunications traffic or projected growth to other carriers. (2) If Sprint materially fails to provide Sprint Real Solutions Annual or Sprint Real Solutions VPN services, the customer will provide prompt written notice to Sprint detailing the failure. If Sprint does not cure the failure within a reasonable time, the customer may, with 30 days' written notice, terminate this Agreement without incurring any termination liability. Sprint's material failure does not include a failure caused by circumstances not within Sprint's sole control including, but not limited to, a failure caused by: (1) a local exchange carrier; (2) customer premises equipment; or (3) the customer. Customer will not receive any promotional credits after the date of its termination notice. (3) If the customer purchases a new service made available by Sprint during the Term as a direct substitute for an existing Sprint contributory service, the customer's services usage charges for the substitute service will contribute to the customer's MAC.
