#### 1. REGULATIONS

#### 1.1 Services by Contract Only

SBC-ASI will offer all services on an individual contract basis only.

Limitation of liability language in the contract does not constitute a determination by the PUCO that the limitation of liability imposed by SBC-ASI should be upheld in a court of law. Approval by the Commission merely recognizes that since it is a court's responsibility to adjudicate liability and consequent damage claims, it is also the court's responsibility to determine the validity of the exculpatory clause.

Services will be provided where facilities permit.

#### 1.2 Services Offered

#### 1.2.1 Switched Multi-megabit Data Service (1)

SBC-ASI offers the high-speed data service of Switched Multi-megabit Data Services at 56 kilobits per second and 1, 4, 10, 16, 25, and 34 megabits per second.

#### 1.2.2 Frame Relay

SBC-ASI offers Frame Relay data services at speeds ranging from 56 kilobits per second (Kbps) up to 40 megabits per second (Mbps).

#### 1.2.3. Asynchronous Transfer Mode

SBC-ASI offers Asynchronous Transfer Mode (ATM) data services at speeds ranging from 1.5 Mbps up to 599 Mbps.

#### 1.2.5 Remote Office Access Manager (ROAM) (2)

SBC-ASI offers Remote Office Access Manager (ROAM) service, which provides dial-up access via the Integrated Services Digital Network (ISDN) or the public switched telephone network (PSTN) to the public broadband network. The dial-up traffic is routed across the broadband network to the appropriate location based upon the network transport protocol utilized. ROAM service is an adjunct to, and is offered only in conjunction with, Switched Multi-megabit Data Service, Frame Relay, or Asynchronous Transfer Mode Service, as described above.

#### 1.2.6 Resale of Local Exchange Facilities

SBC-ASI will purchase all transport services that are offered as a part of its offerings from the tariffs of local exchange companies or other certificated providers of transport services or otherwise as authorized in the Finding and Order of August 19, 1993 in Case No. 93-1081-TP-UNC.
