This postponement is to allow both the Applicant and the Power Siting Staff an opportunity to review the impacts of the Maple Highlands Bike Trail right-of-way and utilization of an abandoned railroad corridor through the City of Chardon as a viable route selection for the proposed transmission line.

Once investigations of this route consideration are complete and the hearings re-open, the applicant will publish appropriate notice in local newspapers of general circulation in the area. Interested persons may testify at only one of the two local public hearings.
