**THE CITY OF CLEVELAND'S OBECTIONS TO THE STAFF REPORT AND
SUMMARY OF MAJOR ISSUES**

The City of Cleveland hereby files its objections to the Public Utilities Commission of Ohio ("PUCO" or "Commission") Staff Report of Investigation for the East Ohio Gas Company d/b/a Dominion East Ohio (DEO). These objections are made pursuant to Ohio Revised Code (R.C.) Section 4909.19 and Ohio Administrative Code (O.A.C.) Section 4901-1-28, which require parties to register disagreement with the Staff Report by formal objection.

The City of Cleveland specifically objects to the Staff Report's recommendation of a rate structure based on a fixed distribution service charge, or a Straight Fixed-Variable (SFV) rate design.¹ The Staff's recommendation rejects the Company's proposed Sales Reconciliation Rider (SRR), or decoupling mechanism, in favor of the SFV rate design. Whether it comes in the form of a SRR, as DEO requests, or a SFV rate design, as the Staff recommends, the City opposes any mechanism or rate design that, in the event customers conserve natural gas or are just low-volume users, guarantees DEO recovery.

The City of Cleveland vigorously promotes energy conservation for its residents and businesses. The SFV creates a disincentive for Cleveland residents and businesses that conserve natural gas. The Staff's recommendation also is contrary to the State of Ohio policy of Conservation as noted in R.C. 4929.02 and 4905.70. The Staff Report even admits that a change from a volume-based rate to a primarily-fixed rate creates a negative impact on low use customers.² Overall, the Staff's recommended SFV design


sends improper price signals to the customer, fails to encourage conservation, and adversely affects DEO's energy efficiency efforts.

SUMMARY OF MAJOR ISSUES

The City of Cleveland submits its Summary of Major Issues pursuant to R.C. 4903.083, which requires the Commission to provide notice to the public of an opportunity to testify at local public hearings regarding the case. In the notice, the Commission must list a brief summary of the then known major issues of the parties. The City of Cleveland's major issues are as follows:

1. Approval of Straight Fixed-Variable (SFV), or similar recovery, is improper and harmful to low-usage customers or customers that conserve natural gas.
2. DEO's consolidation of Case No 08-169-GA-ALT, the Pipeline Infrastructure Replacement Program (PIRP), into this case is inconsistent with the rate-increase principles of R.C. 4909.18 and 4909.19 and improper.
