**CSX Transportation, Inc.'s Motion to Continue
Prehearing Settlement Conference**


CSX Transportation, Inc. ("CSXT"), by and through undersigned counsel, hereby moves the Public Utilities Commission of Ohio to continue the July 23, 2008 prehearing settlement conference. This Complaint concerns certain windows in Towers A, B and C in CSXT's Stanley Yard, Walbridge, Ohio. CSXT has replaced two of the three sets of windows to date. The third tower's window(s) will be replaced Tuesday, July 24, 2008, weather permitting. If weather prevents the installation this week, CSXT will then attempt to replace the windows the following Tuesday. Installing the windows has an impact upon the safe and efficient operation of CSXT's Stanley Yard and must be accomplished on a Tuesday when the Yard is shut-down for maintenance. Because the window replacement is proceeding and nearly complete, CSXT respectfully requests that the Commission continue the July 23, 2008 prehearing settlement conference until August 27, 2008 at 10:00 a.m. to allow CSXT's contractor the time to complete

installation of the windows. The parties anticipate that this Complaint would then be voluntarily dismissed.

The undersigned requested and received the concurrence of the United Transportation Union in this motion to continue the prehearing settlement conference until August 27, 2008 at 10:00 a.m.


