As required by Condition Number 17 of the March 3, 2008 Opinion, Order and Certificate of Necessity and Public Need issued by the Ohio Power Siting Board in the above-referenced matter, and in accordance with the approved Eastern Spadefoot Mitigation Plan and requirements of the Ohio Department of Natural Resources, this letter serves as notice to Staff that American Municipal Power-Ohio, Inc. ("AMP-Ohio") has completed construction of all Eastern Spadefoot breeding pools.

In addition, Eastern Spadefoot tadpoles were successfully translocated on June 19, 2008 and June 24, 2008 as individual pools were completed. AMP-Ohio and its consultants are presently developing legal descriptions and conservation easements to protect the newly construction pools and adjacent habitat.

These activities were completed solely as part of AMP-Ohio's approved Eastern Spadefoot Mitigation Plan. AMP-Ohio has not commenced construction of the American Municipal Power Generating Station but continues pursuit of all necessary permits and authorizations.
