

To Whom It May Concern :

I oppose the increased proposed, by Dominion East Ohio, for raising the flat-rate customer charge because it is unfair to those of us who lower our thermostats to conserve energy and save money. Personally, I have been lowering my thermostat each year. This past year, I took it all the way down to 60 degrees. This was a 5 degree drop from the prior year. I'm considering dropping it to 57-58 degrees this year due to the anticipated rise in the MCF rate. As it is, my current MCF charge for the month, has been lower than all of the "add on" charges. For example, here is the detail of my last bill:

As you can see, if I did not participate in the External Gas Line (m) Program, my gas cost / use is \$4.98. Most of my bill is extra charges. Raising the flat-rate to \$17.50 per month is not acceptable. Sincerely, Brenda M. Haunty



GENTLEMEN:

AS EMPLOYEES OF MHONING COUNTY JOB AND FAMILY SERVICES THAT WORK WITH THE ELDERLY, MEDICAID, WAIVER, AND PASSPORT POPULATIONS, WE ARE SEEING AN ALARMING INCREASE IN THE NUMBER OF PEOPLE WHO ARE MAKING THE DIFFICULT CHOICE BETWEEN PAYING FOR THEIR GAS BILLS OR BUYING THEIR GROCERIES. IN ORDER TO MAKE ENDS MEET, MANY OF THEM TALK ABOUT MOVING IN WITH THEIR CHILDREN, BUT VOICE LEGITIMATE CONCERNS ABOUT "BEING A BURDEN" AND LOSING THEIR INDEPENDENCE. FOR THE MAJORITY OF THEM, THEIR GAS BILLS TRIPLE WHAT THEIR HOUSE PAYMENTS WERE WHEN THEY BOUGHT THEIR HOMES.

WE WERE UNABLE TO MAKE THE MEETING THAT WAS SCHEDULED IN YOUNGSTOWN, OHIO ON AUGUST 19, 2008 TO VOICE OUR CONCERNS ABOUT DOMINION EAST OHIO'S PROPOSED RATE INCREASE MOVING FROM A USAGE-BASED FEE TO A FLAT FEE BUT WISH IT TO BE KNOWN THAT WE STRONGLY OPPOSE THIS INCREASE.

ADDITIONALLY, SPEAKING FOR OURSELVES, WE HAVE NOT HAD A PAY INCREASE IN OVER THREE YEARS, YET SEE OUR OWN GAS BILLS SKYROCKETING, EVEN WITH ADDED INSULATION AND COST-CUTTING CONSERVATION MEASURES.

As a natural gas consumer served by Dominion East Ohio, I would like to comment on the proposed changes for natural gas delivery.


I have no problem with Dominion East Ohio billing its customers with a fixed charge in order to provide a steady income that covers the costs of gas delivery (such as the maintenance and replacement of gas lines), instead of charging an amount based on Mcfs used. Frankly, I think that this is a change that should have been made years ago. Gas delivery has to be reliable, consistent, and safe regardless of how much gas a home owner uses. Pipe lines have to be maintained uniformly whether a home owner is conserving gas in every way possible, or is heating his house with the windows wide open. Those who need motivation to conserve the amount of gas they use should look at the bill they get from their gas supplier.

On the other hand, I DO HAVE A PROBLEM with Dominion East Ohio continuing to include on its bill a usage-based rate, now proposed at \$2.03/Mcf. Dominion East Ohio can't have it both ways. Granted, this is a 30% decrease from the current rate of \$2.90 Mcf, but \$2.03/Mcf will still be a significant impact on a home owner's total bill, particularly during the winter. I would like to see any charge based on usage eliminated completely, and replaced by a flat monthly charge that is calculated to provide Dominion East Ohio with adequate funds to provide gas delivery.

Hopefully, the PUCO has the needed information to assure that such a monthly charge would not be grossly inflated.
