To Whom It May Concern:

We, the undersigned members of the Ashtabula County Board of Commissioners, are writing in support of the new 138KV transmission line that FirstEnergy is proposing to build in Geauga County.

This transmission line would not only serve Geauga County customers, but will also benefit large users in southern Ashtabula County. It will supply reliable energy to several large businesses which employ hundreds of people. Improved electrical reliability and capacity also will be a selling tool in bringing new development to the region.

Representatives from FirstEnergy have explained that without this new transmission line, providing reliable service to our area will be a challenge. Its existing circuits and substations are becoming overextended because of higher usage and growth, and it will be increasingly difficult to maintain voltage levels within the acceptable ranges.

We understand the concerns of residents who live near the proposed routes. However, we believe the project is necessary and should be built. It is critical that a viable solution be selected so that this process can go forward without triggering a protracted legal battle.

The affected region has struggled for years with electric service that is less than satisfactory. We believe that new transmission lines to the area are a must, and are probably 10 years overdue.

We encourage the Siting Board needs to certify either the "preferred" (cross-country) route or the "alternate" (Clay Street) route without further delay.
