## MOTION FOR LEAVE TO FILE OUT OF TIME by COMMUNITIES UNITED FOR ACTION (CUFA) MEMORANDUM IN SUPPORT

CUFA filed a motion to intervene on September 4. CUFA filed electronically, unaware that such filing was not permitted. This error was noted in the Attorney Examiner's September 5 entry, directing that the paper filing be completed by September 12. Unfortunately, counsel was on vacation, failed to note on his return both that entry and the subsequent September 17 entry directing CUFA to refile by September 23.

Both the incorrect use of electronic filing and the failure to comply with the corrective entries were inadvertent oversights and CUFA respectfully requests the Commission grant leave to file and, hopeful that the motion will be granted, has refilled the Motion to Intervene simultaneous with this Motion for Leave.
