Middletown Coke Company (MCC) provides this response to the third list of questions submitted by Ohio Power Siting Board Staff Member, Mr. Tim Burgener.


1. Could you please verify the following statement?

"The Facility will tie into two existing 69 kV lines owned and operated by Duke Energy. The first line would loop the Todhunter to the Carlisle 69 kV line which runs along Yankee Road, and the second line would loop the Todhunter to Manchester 69 kV line which runs along Oxford State Road."

**Response:** The statement above is consistent with the studies that MISO and Duke have been conducting for MCC's interconnection request. Both the Feasibility and System Impact Studies have found no system constraints related to this interconnection plan. 
