

# CAVALIER BUSINESS COMMUNICATIONS' MOTION TO DISMISS

On March 17, 2008, K. A. Florist, dba Segelin's Florist ("Complainant") filed a complaint against Cavalier Business Communications. ("Cavalier") alleging that Cavalier failed to refund Complainant \$227.29. Pursuant to Ohio Administrative Code Rule 4901-9-01(C), Cavalier filed its Answer to the Complaint on August 12, 2008 stating that a refund was sent to Complainant prior to the filing of the complaint (see Attachment A – Affidavit of Mark Clark ). A settlement conference was convened on September 25, 2008 at which time Complainant stated that there was no need for a formal complaint.

Therefore, Cavalier avers that the allegations against Cavalier have been satisfied and settled. Cavalier requests, pursuant to Ohio Administrative Code Rule 4901-9-01(F), that the Complainant be given twenty (20) days to file a written response agreeing or disagreeing with Cavalier's assertion and that, if no response is filed, the Commission may presume that satisfaction or settlement has occurred and dismiss the Complaint.

WHEREFORE, Cavalier respectfully requests the Commission dismiss the Complaint

with prejudice.
