The East Ohio Gas Company d/b/a Dominion East Ohio ("DEO"), Staff of the Public Utilities Commission of Ohio ("Staff") and the Ohio Oil & Gas Association ("OOGA")(collectively, the "Stipulating Parties") hereby provide notice of the substitution of Joint Exhibit 1-A to the Stipulation and Recommendation ("Stipulation") with the attached Substitute Joint Exhibit 1-A.


Joint Exhibit 1-A contained proposed rates for DEO's General Sales Services ("GSS") and Energy Choice Transportation Service ("ECTS") customer classes. Subsequent to the filing of the Stipulation, the Stipulating Parties determined that the rates provided in Joint Exhibit 1-A needed to be amended in order to reflect properly the application of the Gross Receipts Tax Rider. Therefore, adjustment of these rates is necessary for DEO to recover the revenue requirement agreed to in the Stipulation. The correct rates are reflected in the attached Substitute Joint Exhibit 1-A. The correct rates are also reflected in the tariffs filed by DEO with the Commission on October 8, 2008.

The substitution of Joint Exhibit 1-A with Substitute Joint Exhibit 1-A represents a minor technical change and does not alter the substantive position of any party to the Stipulation, including parties identified in Paragraph 3.B of the Stipulation as disagreeing with the rate design reflected in Joint Exhibit 1-A and parties taking no position on the rate design issue.



PROPOSED RATES FOR GSS/ECTS RATE SCHEDULES

Year 1

Service Charge: \$12.50 / month

Volumetric Charge:

First 50 mcf: \$ 0.648 / mcf

Over 50 mcf: \$ 1.075 / mcf

Year 2

Service Charge: \$15.40 / month

Volumetric Charge:

First 50 mcf: \$ 0.378 / mcf

Over 50 mcf: \$ 0.627 / mcf

The Applicability section of the GSS and ECTS rate schedules will be modified to limit eligibility to receive service under the rate schedules to customers consuming less than 3,000 mcf per year.
