Public Utilities Commission of Ohio:

I write in reference to American Electric Power's requested rate increase (08-0917-EL-SSO). I ask that any rate increase be predicated on the provision of reliable electric service, a condition that AEP has never met in the 17 years that I have lived in Columbus.

When I moved to Columbus in August 1991 after living for 15 years in a small town in Georgia, the first difference I noticed between Columbus and Georgia was that Columbus did not have reliable electrical service. Anyone who has lived in Georgia knows its trees are tall and dense, and storms like our recent hurricane winds are routine in Georgia's subtropical climate, yet in the 15 years I lived in Georgia, the electricity went out only 5-6 times and only once for more than a day as the result of an ice storm. When I moved to Columbus in 1991, the electricity was going out every 2-3 weeks. I found this highly disconcerting but was determined not to let it spoil a move that was in every other way positive and exciting. Columbus is a wonderful city!

AEP's service improved somewhat in the latter part of the 1990s, so that we sometimes went 3-4 months between power outages, but after 2000 it began deteriorating again and was soon back to going out every 2 weeks or so. In May 2006, I became so infuriated with AEP's Third World electrical "service," I started keeping track of the outages. I have attached a list of the electrical outages at my home address over the past 30 months, a total of at least 68 (!!) outages, an average of more than 2 per month. Every outage implies loss of data on computers, the resetting of digital clocks, and reprogramming of answering machines, to say nothing of the hazards incurred by residents with serious medical problems.

As frustrating as AEP's unreliable service is to residents, it must cost businesses thousands of dollars annually in lost productivity. How can Ohio recruit new businesses to the state without reliable electric service? AEP's dismal record of performance is not only inexcusable, it is unnecessary. I have lived in 9 locations in 3 states outside Ohio and NEVER have I encountered the incompetence and cavalier disregard for public welfare as that exhibited by AEP.

I urge the PUCO to make any rate hike for AEP strictly conditional on the provision of reliable electric service.
