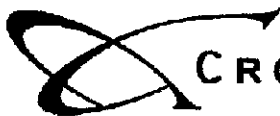

In order to provide our customers with the most up-to-date services and comprehensive customer care, our customers may occasionally experience rate changes to their services. Rate increases are not uncommon in the telecommunications industry. However, First Communications works hard to minimize these occurrences. As of November 15, 2008, the following changes will become effective.

Residential interstate and intrastate long distance rates will increase by \$0.005 (half of penny) per minute.

Residential toll-free customers will begin being charged \$1.25 per toll-free number on a monthly basis.

Payphone Dial Around Surcharge will be \$1.25. The surcharge per call will be added to any completed intrastate toll access code and subscriber toll-free 800/888 type calls placed from a public or semi-public payphone.

Reconnection fee will increase to \$50.00 per occurrence when accounts suspended for non-payment are being restored to service.
