The check to Thompson Hine includes some non-reimbursable items. Cost of Red Flag is \$739.43.

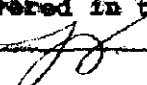
The OSLECA trustees have reviewed the above and agree it comports with the pre-approved authority granted in the December 21, 2005 and October 29, 2008 entries in the above case.
