

Dear Don Morris:

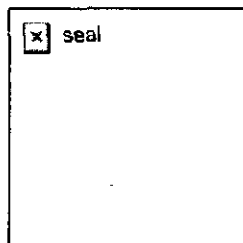
Thank you for your recent email regarding American Electric Power. I appreciate you taking the time to contact me about this matter.
