

(account# 3 5000 3793 9990) same service address for the following reason:

My gas was turned off in April of 2008 and was off until October 21, 2008 during which time I supposedly used 12.7 cubic feet of gas. How can I use gas if it's turned off? The meter was not tampered with according to Steve who turned it off at the street at my request due to the seepage, who is an employee of Dominion East Ohio Gas Co. Steve also informed me that morning that he inspected my meter and that Dominion would try to charge me for the seepage. Steve also told me to inform Dominion that he did inspect the meter.

I am sure that if I were to take the time and research case laws that I would not have to pay for something that I didn't use. If it has to come down to this I will do so and I will hire an attorney and will sue everyone involved for at least \$12 million dollars in a class action lawsuit. It seems senseless that I would have to stoop to suing because someone wants to be greedy. Again I didn't do anything wrong so why should I be punished for a malfunction of Dominion's equipment. Some may say a person like is not being punished but thanks to Columbian and Dominion's screw-ups (allowing bad risers to be approved and installed). Now I lose a source of income, why because of Columbian and Dominion's bad judgement. Again I spent all summer heating my hot water tank with map tanks and at no time did I ever see a pilot light. Since my gas has been turned back on let the record show that I only used 2.7 cubic feet of gas in fifteen days. Now let Dominion show last year's same date and time and explain the difference when nothing has changed except their meter. If anything I feel Dominion owes me due to the malfunction of their meter which should have been changed a little over five years ago. So let's go back five years and see who owes.
