RESPONSE OF UNITED TELEPHONE COMPANY OF OHIO DBA EMBARQ TO THE STAFF'S FIRST SET OF DATA REQUESTS (DATED NOVEMBER 4, 2008)

United Telephone Company of Ohio d/b/a Embarq ("Embarq") hereby provides

its responses to the Staff's First Discovery Request as follows:

1. For the Bellefontaine, Mount Sterling, Sunbury, and Waterville exchanges, there is no E-911 information included with the application for the alternative providers. Is this an oversight? If yes, please provide such information.

Embarq Response:

The exclusion of E-911 information was not an oversight. Embarq provided other data, e.g., directory listings and ported numbers, as evidence to demonstrate the presence of competitors in those exchanges and did not believe it was necessary to provide duplicative E-911 information.

2. For all exchanges where a CLEC (specifically, COI and ValTech) is leasing loops from Embarq, what supporting documentation corresponds to verification of leasing any facilities?

Embarq Response:

The supporting documentation used to verify the CLEC(s) that were leasing loops from Embarq was the Interconnection Agreements between the CLEC(s) and Embarq. Loops and other services were verified from the orders placed by the CLEC(s) with Embarq.
