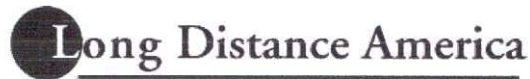

**IMPORTANT RESIDENTIAL CUSTOMER NOTICE**

June 5, 2008

Dear Valued Subscriber:

Beginning on July 1, 2008, the prices, service descriptions, the terms and conditions for long distance services that you are provided by **Long Distance America** will no longer be on file at the Public Utilities Commission of Ohio (PUCO).

This modification does not automatically result in a change in the prices, terms, or conditions of those services to which you currently subscribe. **Long Distance America** must still provide a customer notice at least fifteen days in advance of rate increases, changes in terms and conditions and discontinuance of existing services. Additionally, you will be able to view the company's future service offerings online at [www.ldamerica.com](http://www.ldamerica.com) or you can request a copy of this information by contacting **Long Distance America** at Box 184, Ortonville, MN 56278 or toll-free at 866-469-0829.

Since long distance services will no longer be on file with the Commission, this means that the agreement reached between the customer and the company, instead of the document on file at the PUCO, will now control new services or changes in service. This agreement, whether it is verbal or written, will still be subject to the consumer protections required and enforced by the PUCO.

For any new services or changes in service, it will be important that you carefully review and confirm the price, terms and conditions.
